Introduction

This privacy policy will explain how we HIL Liverpool use the personal data we collect from you when you use our website.

What data do we collect?

Personal identification information (name, email address, phone number, nationality, address, passport and visa information)

How do we collect your data?

You directly provide HIL Liverpool with most of the data we collect. We collect data and process data when you:

- · Register online for any one of our courses.
- Register for any one of our courses in the school.
- Voluntarily complete a customer survey or provide feedback on any of our courses or services (via forms or email).
- Use or view our website via your browser's cookies.
- Voluntarily fill in a consent form to allow us to use your name, photos or videos on our social media and/or website.

How will we use your data?

HIL Liverpool collects your data so we can:

- · Process your order, enrol you into the appropriate course and manage your account
- Keep you updated on any changes regarding your classes and request your feedback on the classes you have attended
- As part of keeping you updated regarding your classes and homework you will be added to a Whatsapp group for your class with your teacher, the other members of your class, and other essential members of staff, which necessarily requires your mobile phone number to be visible to the other members of the class Whatsapp group. As part of your enrolment you will be asked to consent to this use. Please contact us immediately if you do not wish for your data to be used in this way. You will be removed from the Whatsapp group when you end your course of study with us or change classes.
- · Send you digital invoices for payment
- With your express consent, email or text you (mainly via WhatsApp) with special offers and courses we think you may like
- With your express consent, use your photos and videos for marketing purposes on our website and social media channels

When you have successfully enrolled and paid for your course, HIL Liverpool will send you a confirmation email or Whatsapp message containing confirmation of the above.

How do we store your data?

HIL Liverpool security stores your data at our office at 36 Windsor Street, Liverpool, L8 1XF. Most of our data is stored digitally in computers with high measures of security and passwords are changed regularly. However, paper forms are stored in locked filing cabinets inside our offices which are locked with copyrighted keys.

HIL Liverpool will keep your digital and physical data for the duration of your course and kept therein for a period of 2 years. Once this period has expired, we will delete you data from our computers and the recycled bins emptied and any physical data shredded.

What are your data protection rights?

HIL Liverpool would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

The right to access: You have the right to request HIL Liverpool for copies of your personal data.

The right to rectification: You have the right to request that HIL Liverpool correct any information you believe is inaccurate. You also have the right to request HIL Liverpool to complete information you believe is incomplete.

The right to erasure: You have the right to request that HIL Liverpool erase your personal data, under certain conditions.

The right to restrict processing: You have the right to request that HIL Liverpool restrict the processing of your personal data, under certain conditions.

The right to object to processing: You have the right to object to HIL Liverpool's processing of your personal data, under certain conditions.

The right to data portability: You have the right to request that HIL Liverpool transfer the data that we have collected to another organisation, or directly to you, under certain conditions.
